WJW Sporting is a game shooting club which tries to place like minded individuals together to enjoy a day in the field. All individuals taking part in a day's shooting must be members of WJW Sporting. Individual guns cannot be sold or gifted from an individual to anyone (even other members), and must be returned to WJW Sporting to organise a suitable replacement.

In being a member of WJW Sporting, members have acknowledged we strongly advise to take out adequate shoot day insurance to cover adverse weather conditions etc. We also advise all our members are personally insured to cover the unfortunate event of an accident.

A condition of membership is that every member conducts themselves in a professional and mature manner and does not bring the Club's name into disrepute or publish defamatory comments or private information about Westley Wood/WJW Sporting and/or any of the members. Westley Wood will have the power to remove any such individual from the membership without exception.

WJW Sporting will **not** be held responsible for any accident and/or injury incurred by members or visitors and personal property is the sole responsibility of the owner

Once confirmation of your agreed date has been received, an invoice will be sent out for 50% of the total balance, this is a non-refundable deposit. The remainder of the balance will be invoiced and payment date will be agreed prior to your shooting date. The shoot will keep the deposit in the event of the day being cancelled for reasons beyond our control (e.g. severe weather or avian influenza restrictions). We reserve the right to alter any shooting days if extreme circumstances deem this necessary. It is up to the individual teams to take out insurance against such conditions if they wish.

WJW Sporting have the right to refuse membership renewal without exception or explanation. If such a decision is made, an appeal may be made in writing within seven days of receipt of the notification. If no appeal is forthcoming, the refusal will remain in place for the remainder of the year.
